Section 3

Terms and conditions of sale:

A. General

- These conditions apply to every sale made by Metagenics to the customer, and no variation or abrogation will be effective unless evidenced in an authorised writing signed on behalf of Metagenics.
- Metagenics reserves the right not to accept an order placed by the customer, and to change the customer's credit limit, decline credit and close an account, if any terms and conditions are breached.

B. Payment

- Customers approved a 30 day account will pay all invoices within 30 days on the end of the month of delivery of goods.
- If payment is not made by the due date, the customer agrees to accept a charge for interest at the rate of 1.5% per month (18% per annum) calculated on the daily outstanding balance.
- Cash Account customer orders must be paid for within 5 working days, otherwise they will be cancelled.

C. Title and Risk

- Title in the goods remains with the vendor, and does not pass to the customer until Metagenics has been paid in full, in cleared funds.
- Risk in the goods passes to the customer on delivery.

D. Practitioner Only Range

Metagenics, UltraBalance, Innovative Therapies and Classic TCM are Practitioner only ranges that can only be supplied by a registered Healthcare Practitioner in a consultation situation, or through the Patient Order System. No Metagenics, UltraBalance, Innovative Therapies or Classic TCM products, signs or logos are to be on display in a retail environment. All products are to be kept out of retail sight and only supplied in the context of personal consultation by a registered Practitioner. The customer must not advertise or supply the Practitioner Only Range via the internet, other than via a secure log-in section for patients only.

E. Ordering and Despatch

Our order department is open to receive orders between 8:00 a.m. and 5:15 p.m. Monday to Friday. Every reasonable attempt will be made to despatch orders received prior to 2:00 p.m. on the day of receipt of order. Orders received after 2:00 p.m. will be despatched the following business day.

F. Credits and Returns

No credit will be processed for returned goods unless:

- the goods were supplied in error; or
- the goods were damaged in transit; and
- a request for credit is to be lodged within 24 hours of receipt, and
- the goods are to be returned within 7 days and accompanied by an approved Return Authority Number and signed return assessment form issued by Metagenics.

I/we acknowledge that I have read and agreed to the Terms and Conditions of Sale above, and that:

- I hereby authorise Metagenics to make any enquires or exchange or disclose any information concerning my/our credit worthiness from or to any person or source as considered appropriate by Metagenics.
- If granted credit, I/we agree to pay all invoices within 30 days of the end of the month.
- It is agreed that I/we will pay 1.5% per month which is 18% yearly on all past due balances.
- My/our financial condition is satisfactory and I/we can meet all financial obligations.
- There are no lawsuits or judgements against me/us at this present time. If I/we default on payment of any outstanding valid invoices I/we agree to pay attorney and/or collection expenses.
